Pareto - Review of Financial Activities 2013

The Pareto Uppsala Economic Association started its fourth year with a small amount of funds due to almost no income in the previous fiscal year. A lot of what the association owned where tied up in merchandise.

Because of the critical shortage of funds, Pareto did not hold a lot of events or academic activities during spring 2013. Instead, the focus was put on dealing with a short and long term financial plan. It was decided that Pareto will change its objectives and target only Master's students in the Economics Programme. Pareto received a donation of 3500 SEK from the Economics Department as well as a contribution of 600 SEK from Folkuniversitetet during the year. Furthermore, the preceding board had ordered merchandise (47 bags) which had not been accounted for previously (as there have not been any recorded costs). These were given to the current board and are the reason why the balance sheet for this year is positive. Income was also generated through the sale of merchandise. Through arranging both social and academic activities each month in autumn 2013, Pareto managed to gain new members to its Board and association.

The budget for this year shows that the association had expected to receive only 1.550,00 SEK in income but instead the actual amount received was 8.595,57 SEK. This is explained through the grant received from the Economics Department in order to allow the association to expand its activities. Also, as mentioned earlier, merchandise which are unaccounted for were given to the current Board. The amount budgeted for the expenses this year was also estimated to be higher than what was actually used. This is due to the fact that Pareto was expecting to be able to start conducting study visits which was estimated to a cost of 10.000 SEK. The amount of expenses spent on academic activities for this year is slightly higher than what was projected. The social activities was budgeted at 2000 SEK with only 75,60 SEK actually spent. This is because most of the social activities arranged by Pareto this semester did not utilize any costs or were held together with the Economics Department. Another expense that should be highlighted is the sale of merchandise. In the budget, the association was not expecting to use any of the merchandise; however, the new Board has managed to decrease the amount of merchandise by giving away the merchandise as prizes or selling them.

After a full year of activity, Pareto seems to be more stabilized financially than last year. I emphasize, like the previous treasurers, that a clear long term financial plan should be made as Pareto currently do not have a plan for future income.
